OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate income and some growth over the long term (5 years or more) by investing in listed closed ended real estate investment trusts ('REIT's') and equities (company shares) of companies engaged in real èstate activities.

Performance Target: To achieve the return of the FTSE EPRA Nareit Developed Net Return Index(Hedged to GBP) + 2% per annum over rolling three year periods (before charges). There is no certainty or promise that the Performance Target will be achieved. The FTSE EPRA Nareit Developed Net Total Return Index (Hedged to CPD) (the "Index") is the performance the performance that the Performance Target will be achieved.

Portfolio Securities

- The fund invests at least 70% in global property related equities. - The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

Management Process

The management process
The management team use their discretion (active management) to maintain a diverse asset mix at country and company level.
Their primary focus is on company selection using research techniques to select individual holdings. The research is focused on identifying companies the management team believe will increase in value and which align with their views regarding future economic and business conditions.


