#### **Objectives and Investment Policy**

Templeton Asian Growth Fund (the "Fund") is classified as Article 8 under EU Sustainable Finance Disclosure Regulation and aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

- equity securities issued by companies of any size traded on stock exchanges in Asian countries (excluding Australia, New Zealand and Japan)
- equity securities issued by companies of any size located in, or doing significant business in, Asian countries (excluding Australia, New Zealand and Japan)

The Fund can invest to a lesser extent in:

- equity or debt securities issued by companies of any size located in any country in the Asia region, including any other emerging markets in the Asia region
- equity securities of companies located outside of the Asia Region but which derive a significant proportion of their revenues or profits from the Asia region
- securities issued by private companies (limited to 5% of the Fund's assets)
- derivatives for hedging and efficient portfolio management

The investment team uses in-depth financial analysis to select individual securities that it believes will provide the best opportunities for increased value over the long term.

The benchmark of the Fund is the MSCI AC Asia ex-Japan 10/40 Index-NR - Linked. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark

You may request the sale of your shares on any Dealing Day (as defined in the current prospectus of the Fund).

#### **Terms to Understand**

#### Why is the Fund in this specific category?

The Fund invests mainly in equity securities of companies located in or doing significant business in Asia. Emerging markets have historically been subject to significant price movements, frequently to a greater extent than equity markets globally. As a result, the performance of the Fund can fluctuate

significantly over relatively short time periods.

#### Risks materially relevant not adequately captured by the indicator:

Chinese Market risk: In addition to typical risks linked to Emerging Markets, investments in China are subject to economic, political, tax and operational risks specific to the Chinese Market. 
