OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate growth over the long term (5 years or more) by investing in UK mid-capitalisation equities (company shares).

Performance Target: Performance Target: To achieve the return of the FTSE 250 ex Investment Trusts Index plus 3% per annum over rolling three year periods (before charges). There is no certainty or promise that the Performance Target will be achieved. The FTSE 250 ex Investment Trust Index (the "Index") is a representative

index of the stock market for the UK mid-sized companies.

Investment Policy

Portfolio Securities

- The fund will invest at least 60% in equities of UK mid-sized companies. - UK mid-sized companies are defined as any company of a size similar to those in the Index. - The fund may also invest in smaller and larger UK companies.

- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

Management Process

- The management team use their discretion (active management) to maintain a diverse asset mix at sector and company level.

- Their primary focus is on company selection using the management team's quality, growth and momentum approach. It aims to identify companies that show a range of high quality characteristics, have the ability to deliver sustained long term growth and are displaying positive growth in their earnings.

- Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the Index. Please note: The fund's ability to buy and sell smaller and mid-sized companies and the associated costs can be affected during periods of market stress. In certain circumstances investors in the fund may not be able to sell their investment when they want to.


