## Objectives and Investment Policy

### Objective

We seek to grow the Fund by 4% per year more than the Consumer Price Index (CPI) over a rolling 5 year period after deducting fees and costs.

### Investment Policy

In normal market conditions we invest at least 75% of the Fund in the shares of companies from around the world. We may however hold more or substantially less than 75% of the fund in shares when we deem it appropriate in order to manage difficult market conditions. We also invest in derivatives to manage the risk associated with investments in shares. Derivatives are financial contracts whose value is linked to the price of another asset (e.g. indices, rates, share prices, currencies). We may also invest in cash or bonds or units in funds (including those managed by Sarasin).

We carefully select the Fund's investments and have free choice to select companies from any country/region, sector or industry. We identify the long-term investment themes that drive growth and lead to disruption in global economies and industries, and will shape the world in which we live and invest. We select companies based on our own analysis of which are most likely to benefit from our themes, and are well placed to grow their revenues and cash flows as a result of them

We use derivatives to adjust how sensitive the Fund is to changes in currencies - whether to act on opportunities or control risk, to gain cost-effective access to investments, and to generate income.

We usually aim for the Fund's exposure to Sterling to be the same as the blended benchmark (around 55%).

The Fund's performance can be assessed by reference to a blended benchmark of:

- 45% - MSCI All Countries World Index (NTR);
- 30% - MSCI All Countries World (Local Currency - GBP);
- 17.5% - Bank of England SONIA;
- 7.5% - Bank of England SONIA +2%

### Distribution Policy

Any income due from your investment may be paid out to you.

### Dealing Frequency

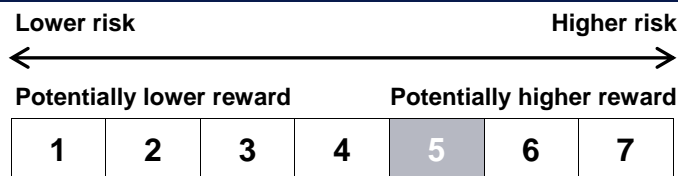
You can buy and sell shares in the Fund before 12 noon GMT on any business day in London.

## Risk and Reward Profile



The Risk and Reward Indicator table demonstrates where the fund ranks in terms of its potential risk and return, calculated using the volatility of monthly returns over five years. As it is based upon how the fund has performed in the past, you should note that the fund may well perform differently in the future. The risk category shown is not guaranteed and may shift over time.

The higher the rank the greater the potential reward but the greater the risk of losing money.

The Fund is ranked at 5 reflecting observed historical returns. The fund is in this category because it has shown higher levels of volatility historically.

The following risks may not be fully captured by the Indicator:

- **Counterparty and Settlement Risk:** The fund may enter into derivative transactions in over-the-counter markets, which will expose the fund to the credit risk of their counterparties. The fund may be exposed to the risk of settlement default where the counterparty may default on its obligations to perform under the relevant contract. In the event of the bankruptcy or insolvency of a counterparty, the fund could experience delays in liquidating the position as well as significant losses, including declines in value during the period in which the fund seeks to enforce its rights.
- **Leverage:** This means that the exposure to the underlying market or asset may be greater than 100%. Leverage has the potential to magnify gains or losses on the underlying asset/market. You should be aware that, if the underlying asset/market moves in the opposite direction to that anticipated, the losses incurred will be greater in percentage terms than those incurred by a direct investment in the underlying asset/market itself. The prices of leveraged products can therefore be volatile.
- **Derivatives:** If a derivative transaction is particularly large or if the relevant market is illiquid (as is the case with many privately negotiated derivatives), it may not be possible to initiate a transaction to liquidate a position at an advantageous price, to assess or value a position or to assess the exposure to risk. An adverse price movement in a derivative position may also require a cash payment to counterparties that might in turn require, if there is insufficient cash available in a fund, the sale of investments under disadvantageous conditions.

- **Market Risk:** This is a general risk that the value of a particular derivative may change in a way which may be detrimental to the Funds' interests and the use of derivative techniques may not always be an effective means of, and sometimes could be counter-productive to, the Funds' investment objectives.
- **Emerging Market Equities Risk:** Emerging markets may face more political, economic or structural challenges than developed markets and shares may be less liquid, meaning that investments may not be sold quickly enough to prevent or minimize a loss; they may therefore involve a higher risk than investing in developed markets.
- **The fund has charges deducted from capital.** This may reduce the potential for growth.
- **Alternatives Risk:** Some alternative investments may have lower trading volumes than other securities. In some cases this may make such investments harder to sell at the last quoted market price, or at a price considered to be fair. Such conditions could result in unpredictable changes in the value of your holding.

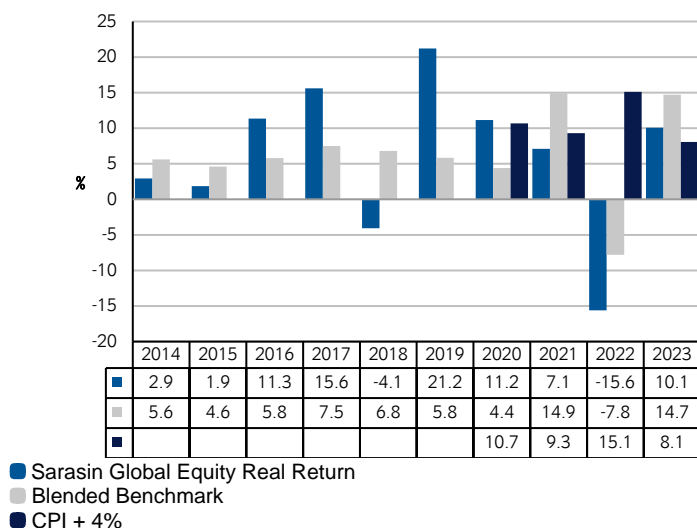
## Charges
