## SVS Saltus Real Return Fund I Income Shares [ISIN: GB00BGHQ1098]

The Fund is a sub-fund of SVS Saltus Onshore Portfolios. The Authorised Corporate Director of the Fund is Evelyn Partners Fund Solutions Limited, part of the Evelyn Partners group.

### **Objectives and investment policy**

The Fund aims to generate a positive absolute return over the medium term (rolling 3 year periods).

The Fund will invest at least 80% in other investment funds which themselves invest in:

equities and fixed income securities (including but not limited to shares and bonds issued by governments and other organisations)
cash, deposits and money market instruments

- currencies
- gold
- property
- warrants
- derivatives

The Fund focusses on exposure to alternative investments, but seeks to identify opportunities which the investment manager considers have a low risk and volatility profile, in keeping with the investment objective of the Fund.

The Fund may also invest directly in the asset classes listed above with the exception of derivatives and property.

Investors should note that their capital is at risk and that the investment objective is intended as a target figure and not any form of guarantee.

The investment policy will create a widely diversified portfolio of investments across multiple asset classes, geographies, styles and strategies.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital. The Fund may use derivatives and forward transactions for investment purposes on the giving of 60 days' notice to Shareholders. The use of derivatives for investment purposes may alter the risk profile of the Fund.

Any income the Fund generates will be paid out to you.

You can buy and sell shares on any working day in London.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking the benchmark nor is the Fund constrained by the value, price or components of that benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

#### **Risk and reward profile**
