OBJECTIVES AND INVESTMENT POLICY

- The objective of the Fund is to track the performance of the FTSE 250 ex. Investment Trusts Index, the "Benchmark Index" on a net total return basis before fees and expenses are applied. Fund performance may differ from of risk. the Benchmark Index due to the deduction of fees and expenses and the Other information: impact of any tracking error factors.
- The Fund will invest 80% (directly or through depositary receipts (a certificate issued by a bank representing shares in a foreign company such as American depositary receipts and global depositary receipts)) in the assets that are included in the Benchmark Index.
- The Fund's investments will closely match those that make up the Benchmark Index.
- The Benchmark Index is comprised of shares in all eligible middle capitalisation companies (excluding investment trusts) listed on the London Stock Exchange's (LSE) main market, which pass screening for size and Iliquidity in accordance with the index provider's methodology. The Fund may also invest in money market instruments (such as treasury
- bills), depositary receipts, cash, deposits, shares in companies which are reasonably expected to become part of the Benchmark Index in the near future or are an alternative to a constituent of the Benchmark Index and collective investment schemes, including those managed or operated by the Manager or an associate of the Manager.


