Objective and Investment Policy

Investment Objective

The objective of the Sub-fund is to provide capital growth over any 7 year period and to provide income.

How will the objective be achieved?

A minimum of 70% of the portfolio will be invested in collective investment schemes to provide diversified exposure to property. This will include investments that are linked to property as well as investments that hold direct property (known as bricks and mortor investment). The maximum exposure to collective investment schemes that invest directly in property will be 50% (defined as having more than 70% of their assets directly in immovable properties).

The Sub-fund may also invest directly (maximum of 30%) in shares, bonds, cash, near cash instruments, investment trusts, real estate investment trusts (REITs) and structured products which may embed derivatives.

Management Style

The Sub-fund is actively managed, meaning that the manager selects investments, rather than tracking a stock exchange or index.

Derivative Use


The use of derivatives and/or hedging transactions are permitted in connection with the efficient portfolio management (EPM - managing the Sub-fund in a way that is designed to reduce risk or cost and/or generate extra income or growth or both). The scheme may hold assets which embed derivatives that are used for investment purposes and efficient portfolio management, although this would not materially affect the risk exposure of the scheme.

General

Shares in the Sub-fund can be bought and sold daily (every Business Day of the Sub-fund). If you invest in income shares, income from investments in the Sub-fund will be paid out to you. If you invest in accumulation shares, income will be retained in the value of your shares.

Recommendation: this Sub-fund may not be appropriate for investors who plan to withdraw their money within 7 years.

Risk and Reward Profile


