Objectives and investment policy

The fund aims to provide capital growth and income of the ICE BofA Sterling 3 Month Government Bill Index + 4% per annum (before fees have been deducted*) over rolling three year periods by investing in a diversified range of assets and markets worldwide. The fund also aims to target a volatility (a measure of how much the fund's returns may vary) range of 4% - 8% over the same period. Investment Policy

The fund is actively managed and invests directly, or indirectly through collective investment schemes, exchange traded funds, real estate investment trusts and closed ended funds, in equities, bonds, commodities and currencies worldwide. The weightings of these holdings are adjusted in response to changing market conditions.

The fund may invest more than 10% of its assets in collective investment schemes (including other Schroder Funds).

The fund may invest in below investment grade securities (as measured by Standard & Poor's or any equivalent grade of other credit rating agencies) or in

unrated securities.

The fund may also invest in warrants and money market instruments, and may hold cash

The investment strategy of the fund and its use of derivatives may lead to situations when it is considered appropriate that prudent levels of cash or cash equivalent liquidity will be maintained, which may be substantial or even represent (exceptionally) 100% of the fund's assets.

The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.
