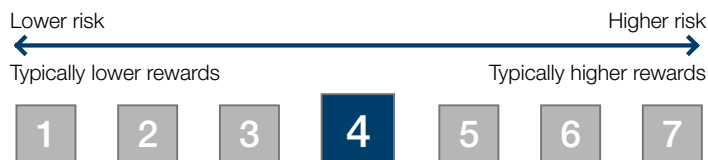
(ISIN:IE00BYP55G81) Man GLG Innovation Equity Alternative (the 'Fund') is a sub-fund of Man Funds VI plc (the 'Company').

Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

Objectives and investment policy

- The Fund seeks to provide investors with absolute returns (meaning that it seeks to achieve returns irrespective of market conditions) by investing primarily in shares and related instruments of companies globally. The Fund will gain exposure to shares on markets listed globally.
- The Investment Manager will focus on companies that operate in sectors which are susceptible to the impact of change and innovation (including technology, media, retail, automotive, telecommunication and industrial sectors). The Investment Manager selects the companies in which to invest on the basis of detailed screening criteria which seeks to identify companies whose shares have been mispriced. The Fund will typically be primarily invested in large capitalisation companies (with a market capitalisation greater than USD 1 billion). The Fund will not have any particular sectoral focus but may be concentrated in a limited number of sectors from time to time. The Fund will invest in companies globally, with a particular focus on US markets.
- The Fund may pursue a 'long-short strategy' whereby, in addition to buying and holding assets which the Investment Manager believes to be undervalued, it may use financial derivative instruments (ie instruments whose prices are dependent on one or more underlying assets) ('FDI') to take 'short' positions where the Fund may make money in respect of issuers whose securities the Investment Manager believes to be overvalued or expects to fall in value.
- The Fund may actively use FDI to achieve the investment objective, for hedging a given instrument or against anticipated movements in a market or other sector or where it is more cost effective than directly holding the underlying asset. The use of FDI may multiply the gains or losses made by the Fund on a given instrument or on its investments generally. FDI may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage).
- The Fund is actively managed; no benchmark is used as a universe for selection or for performance comparison purposes.
- In addition to the above, the Fund may also invest in a number of other assets including currencies, money market instruments, debt securities, other funds, cash and other liquid assets. Debt securities can be issued by either government or corporate issuers and may be rated investment grade or non-investment grade. The Fund may increase its holdings of cash and other liquid assets in times of market turbulence.
- The Fund promotes, among other characteristics, environmental and social characteristics within the meaning of Article 8 of the Sustainable Finance Disclosure Regulation (SFDR). The Fund commits to a minimum proportion of sustainable investments through the application of the Investment Manager's proprietary 'SDG Framework' to measure issuer alignment to the UN Sustainable Development Goals (SDGs) and therefore contribution to environmental/social objectives as applicable. The Investment Manager will apply an exclusion list of controversial stocks or industries which may be related to arms and munitions, nuclear weapons, tobacco and coal-oriented activities. In addition the Investment Manager will typically exclude companies that are determined to be in non-compliance with the United Nations Global Compact.
- The extensive use of FDI, and the fact that FDI may only require a small upfront payment, may mean the Fund is consistently required to hold a substantial portion of its assets in bank deposits and other money market securities.
- The Fund will use FDI to provide investors with a similar return to any share class issued in the working currency of the Fund (USD).
- The Fund's reference currency is USD.
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.
- Investment in the Fund is suitable for medium to long-term investors.

Risk and reward profile

The following risks may not be fully captured by the risk and reward profile:

- The Fund may make investments or hold trading positions in markets that are volatile and which may become illiquid. Timely and cost efficient sale of trading positions can be impaired by decreased trading volume and/or increased price volatility.
- The value of investments designated in another currency may rise and fall due to exchange rate fluctuations. Adverse movements in currency exchange rates may result in a decrease in return and a loss of capital. It may not be possible or practicable to successfully hedge against the

currency risk exposure in all circumstances.

- The Fund will invest financial derivative instruments ("FDI") (instruments whose prices are dependent on one or more underlying asset) to achieve its investment objective. The use of FDI involves additional risks such as high sensitivity to price movements of the asset on which it is based. The extensive use of FDI may significantly multiply the gains or losses.
- The Fund's use of FDI may result in increased leverage which may lead to significant losses.
- The Fund will be exposed to credit risk on counterparties with which it trades in relation to on-exchange traded instruments such as futures and options and where applicable, 'over-the-counter' ("OTC", "non-exchange") transactions. OTC instruments may also be less liquid and are not afforded the same protections that may apply to participants trading instruments on an organised exchange.
- The Fund focusses on a limited number of industries therefore, may be susceptible to greater risks and market fluctuations than investment in a broader range of investments covering different economic sectors.
- The currency hedging used for this share class to minimise the effect of certain exchange rate fluctuations may not be completely successful and currency hedging transactions will involve counterparty risk.
- The Fund is subject to normal market fluctuations and the risks associated with investing in international securities markets and therefore the value of your investment and the income from it may rise as well as fall and you may not get back the amount originally invested.
- There is no guarantee that the Fund will achieve its investment objective.

Charges

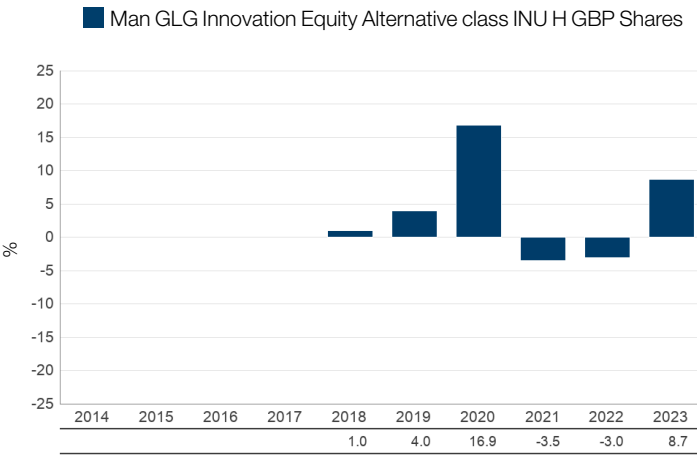
