Objectives and investment policy

The UBS FTSE RAFI Developed 1000 Index Fund (the "Fund") seeks to track the return of the FTSE RAFI Developed 1000 Total Return Net GBP – QSR Index (the "Index") before the deduction of charges. The Fund employs a passive investment strategy, investing all, or substantially all, of its assets in the shares of companies that make up the Index. To the extent that the Fund is not fully invested in the constituents of the Index, it may be invested in shares of companies which in the Manager's opinion are reasonably expected to become part of the Index. The Index is comprised of 1000 large, medium and small companies in developed markets, selected and weighted using a composite of fundamental factors, including total cash dividends, free cash flow, total sales and book equity value. FTSE Russell® is a trade mark owned by the London Stock Exchange Group companies and is used by FTSE Russell International Limited under licence. The FTSE Russell RAFI® Index Series is calculated by FTSE Russell International Limited ("FTSE Russell") in conjunction with Research Affiliates LLC ("RA"). - The Fund aims to have an Anticipated Tracking Error of up to 0.5% per annum. The Anticipated Tracking Error is a target and is not guaranteed.
- The Fund may use derivatives (financial instruments whose value is linked to an underlying asset or index) for the purposes of efficient portfolio management.

Investors can buy or sell shares every UK working day except the last working day before Christmas and when the NYSE or NASDAQ are closed.

The income in respect of an accumulation share class is not distributed but is retained in the Fund and reflected in the share price.

The Fund is denominated in GBP (Sterling). As such, investors may be exposed to changes in the exchange rate between the underlying currency of the Fund's assets and GBP which may have a negative or positive impact on the returns.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years of investment.

Why is this fund in Category 6?

The fund is in category 6 because the volatility of past returns of the Index has been very high.

No capital guarantee for this Fund exists so investors could lose the whole of their investment. A more detailed list of the risks can be found in the "Risk Factors" section of the prospectus.

The risk indicator may not fully take into account the following risks.

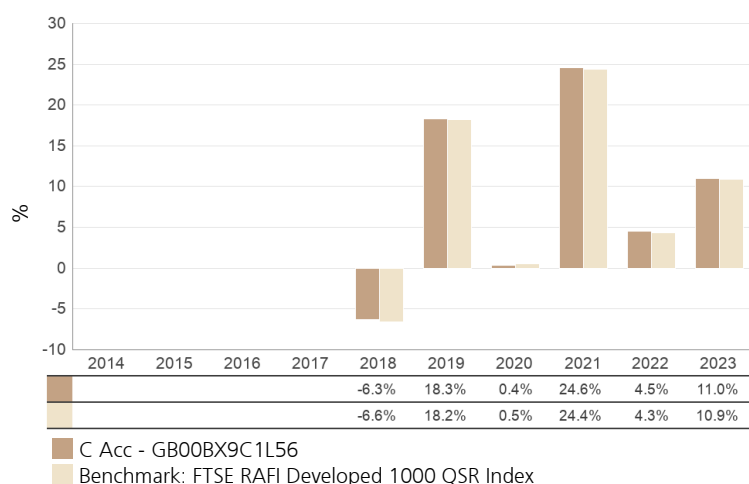
The **entry** and **exit charges** shown are maximum figures. In some cases you might pay less – you can find this out from your financial adviser.
