The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited (the "Manager").

#### **OBJECTIVES AND INVESTMENT POLICY**

- The objective of the Fund is to track the performance of the FTSE All-World An overview of the Benchmark Index is available on FTSE's website: ex CW Climate Balanced Factor Index, the "Benchmark Index", on a net climate balanced factor overview total return basis before fees and expenses are applied. Fund performance may differ from the Benchmark Index due to the deduction of fees and expenses and the impact of any tracking error factors.
- The methodology of the Benchmark Index is designed to reflect the performance of a global and diversified basket of shares in companies where their weights are varied (i) to achieve balanced exposures to certain equity factors being value, quality, low volatility and size factors and (ii) to account for risks and opportunities associated with climate change. Specifically, reducing exposure to companies that own or are engaged in the exploration or production of fossil fuels or the suppliers of equipment and services to the fossil fuel industry. The Manager may exclude shares of companies in the Benchmark Index
- that do not meet minimum standards in line with the Investment Manager's "Climate Impact Pledge", for example disclosure of total carbon footprint. The number of companies excluded will be managed to avoid tracking error.
- The Fund seeks to replicate the Benchmark Index as closely as possible and will have at least 90% exposure to its constituents and will generally hold assets directly but can use depositary receipts (such as American depositary receipts and global depositary receipts) to gain exposure when the direct asset cannot be held or is not available.
- The Fund may also invest in shares in companies which are reasonably expected to become part of the Benchmark Index in the near future or are an alternative to a constituent of the Benchmark Index, money market instruments (including treasury bills), depositary receipts, cash, deposits, and collective investment schemes including those managed or operated by the Manager or an associate of the Manager.
- The Fund may use derivatives (contracts which have a value linked to the price of another asset) for efficient portfolio management purposes to:

#### Other information:

- The Fund is passively managed as it tracks the Benchmark Index, less those excluded by the Climate Impact Pledge and Future World Protection
- Your units will be income units. Income from the Fund's investments will be paid out to you every six months (as dividends). This will reduce your capital growth accordingly.

#### **RISK AND REWARD PROFILE**



- The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. - The Fund is in category 5 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time. Company shares are generally considered to be higher risk investments than bonds or cash.

The Fund invests directly or indirectly in smaller companies. Investments in smaller companies tend to be riskier than investments in larger companies because they can: (i) be harder to buy and sell; or (ii) go up and down in value more often and by larger amounts, especially in the short-term. In times of market uncertainty or if an exceptional amount of withdrawals are

- The Fund has a sustainability and/or ESG focus in its investment process which may i) limit the Fund's exposure to or exclude certain companies, industries or sectors ii) impact the Fund's investment performance compared
- to other funds that do not apply such criteria and, iii) differ from an investor's own sustainability and/or ESG criteria.

  The Fund may have underlying investments that are valued in currencies that are different from GBP. Exchange rate fluctuations will impact the value of your investment. Currency hedging techniques may be applied to reduce this impact but may not entirely eliminate it.


**Dilution adjustment:** On any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'

This can vary but as an example for this Fund we estimate 0.12% for purchases and 0.08% for sales at 31 December 2023. The amount of the

dilution adjustment may differ in future.
