OBJECTIVES AND INVESTMENT POLICY

Objective

- Long term growth of your investment

Main Investments

- At least 70% of the Fund's investments will be in company shares, including depositary receipts and China A-Shares via Stock Connect.

Investment Policy

- To invest in companies, located in Asia excluding Japan, that the investment adviser believes have sustainable competitive advantages and are undervalued at the time of investment.
- As an essential and integrated part of the investment process, the Investment Advisor assesses relevant factors material to long-term sustainably high returns including ESG factors and seeks to engage with company management teams as part of this.
- The Fund includes tobacco, climate- and weapons-related exclusions, the details of which may be found in the Fund's Restriction Screening policy on the Company's website (www.morganstanleyinvestmentfunds.com and at www.morganstanley.com/im).
- The Fund will measure its performance against the MSCI All Country Asia ex-Japan Net Index (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

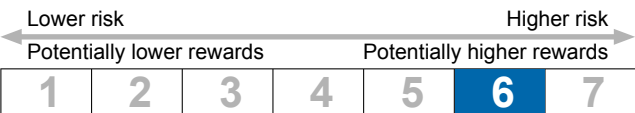
Other Information

- The Fund may invest up to 30% of its assets in investments that do not meet the above criteria.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Financial Derivative Instruments' section) for more details.
- Income will be included in the value of your shares.
- There are higher costs involved in buying and selling shares in this region. These costs reduce the value of your investment but are not included in the Ongoing Charges figure below.

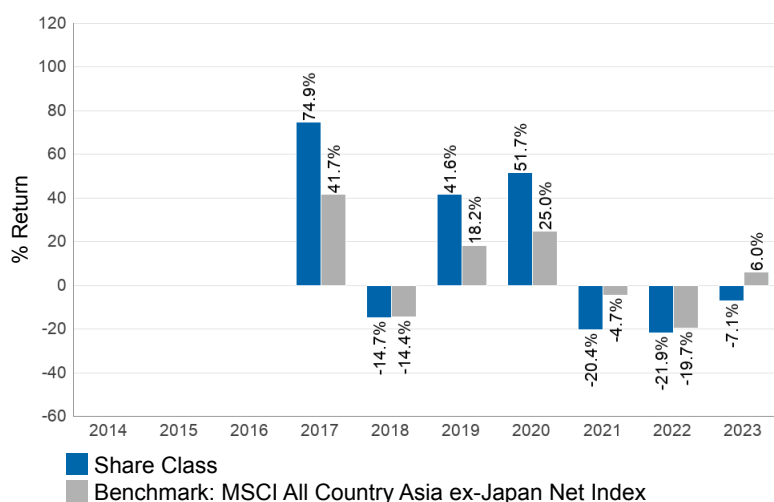
The entry and exit charges shown are maximum figures. In some cases you might pay less, you can find this out from your financial adviser.
