OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate growth over the long term (5 years or more) by investing in US and Canadian small and mid-capitalisation equities (company shares).

Performance Target: To achieve the return of the Russell 2500 Index plus 3% per annum over rolling five years periods (before charges). There is no certainty or promise that the Performance Target will be achieved.

The Russell 2500 Index (the "Index") is a representative index of the stock market for the US small and mid-sized companies.

Investment Policy

Portfolio Securities

- The fund will invest at least 70% in equities of small and mid-sized - menuines of the United States of America (US) and Canada. - US and Canadian small and mid-sized companies are defined as any

company of a size similar to those included in the Index.

- The fund may also invest in larger US and Canadian companies - Investment in Canadian companies are not expected to exceed 20% of the fund.

- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

Management Process

- The management team use their discretion (active management) to maintain a diverse asset mix at sector and company level.

- Their primary focus is on selecting companies using research techniques to select individual holdings. The research process is focused on finding attractive high quality companies that can be held for the long term through the assessment of their business, the industry they operate in, their financial strength and the capability of their management team. - Due to the active nature of the management process, the Fund's performance profile may deviate significantly from that of the Index. - Please note: The fund's ability to buy and sell small and mid-sized


