What is this product?

This is a closed ended investment trust.

Investment Objective and Policy

Investment Objective: The principal investment objective of the Company is to achieve capital growth from an actively managed portfolio principally comprising securities listed on the Japanese stock markets, with the aim of achieving growth in excess of the TSE First Section Total Return Index in sterling over the longer term.

Investment Policy: The Manager utilises an active stock driven investment approach, drawing on Schroders' extensive research resources in Japan. The portfolio is principally invested in a broad range of companies quoted on the Tokyo Stock Exchange, the regional stock markets of Fukuoka, Hiroshima, Kyoto, Nagoya, Niigata, Osaka and Sapporo and the Japanese over the counter (OTC) market. Investments may also be made in companies listed elsewhere but controlled from Japan or with a material exposure to the Japanese economy. There are no constraints on size of company or sector allocation. This flexibility will allow the Manager to take advantage of changes in market sentiment and in the domestic economic cycle as it develops. The portfolio is mainly invested in equities but may also be invested in warrants, convertibles and other derivative instruments where appropriate. The Company may invest up to 5% of its assets in securities which are not listed on any stock exchange, but would not normally make such investment except where the Manager expects that the securities will shortly become listed on a Japanese stock market.

The Company may use gearing (including the use of CFDs) to enhance performance but investment exposure will not exceed 125% of net asset value.

Benchmark: The Company aims to achieve growth in excess of the TSE First Section Total Return Index in sterling over the longer term.


Distribution Policy: This share class pays an annual distribution at a variable rate based on gross investment income.

Intended retail investor

This product may be suitable for retail investors seeking a longer term investment in Japanese shares as part of a diversified portfolio, who have at least a basic knowledge of stock market investing and are able to understand the product's strategy, characteristics and risks in order to make an informed decision to invest and have sufficient resources to bear any loss which may result from the investment.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years. The risk is considered to be higher if the holding period is shorter.

We have classified this product as 5 out of 7, which is a medium-high risk class.

The Company is in this category because it can take higher risks in search of higher rewards. This category rates the potential losses from future performance at a "medium" level, and poor market conditions will likely cause shareholders to lose money.

The following factors serve to increase risk and may lead to higher volatility in the Company's share price: it invests in assets which are exposed to currencies other than sterling; it invests solely in the securities of a particular country; it may use derivatives for specific investment purposes; and it has borrowed (or "geared") to purchase assets.

Liquidity risk: In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares.

Investment performance information

Future returns on your investment will be determined by the performance of the Japanese shares held in the Company's portfolio. Such performance may be positive or negative, depending on a number of factors such as profitability, management and financial health of the underlying companies and general movements in the Japanese stock markets. General movements in the Japanese stock markets could be a result of political, regulatory, market, economic or social developments at a local, regional and global level.

In addition, the currency of the Japanese shares held in the Company's portfolio is Japanese yen, whereas the currency of the Company's shares is sterling, so movements in the Japanese yen/sterling exchange rate may have a material impact on the performance of the product.

The most relevant benchmark for measuring the product's performance is the Tokyo Stock Exchange First Section Total Return Index measured in sterling. This benchmark has been selected because its underlying stock components are representative of the type of companies in which the Company is likely to invest. However, the Company may invest in other shares that are not part of the benchmark. As a result, the performance and volatility of the Company's shares may vary from that of the benchmark.

What could affect my return positively?

Higher returns may be generated where Japanese stock markets rise in value and if the Japanese yen appreciates against sterling.

Such conditions could therefore lead to an investment gain in the product.

What could affect my return negatively?

Lower returns may be generated where Japanese stock markets fall in value and if the Japanese yen depreciates against sterling.

Such conditions could therefore lead to an investment loss in the product.

The product does not have a maturity date. In difficult market conditions, investors may receive less than the amount they invested on a sale of the product. Under severe market conditions, for example a significant fall in the value of Japanese stock markets and a significant depreciation of the yen against sterling, investors may receive considerably less than the amount they invested on a sale of the product and, in an extreme situation, may lose all of their money invested in the product.

What happens if Schroder Japan Growth Fund plc is unable to pay out?

You may sell your shares at any time on the London Stock Exchange using your broker. Your shares are sold to another buyer in the market without recourse to the Company. If the Company goes into liquidation the investments will be sold and you will receive your pro rata share of the proceeds after settlement of any liabilities. You would not be entitled to compensation from the Financial Services Compensation Scheme.

What are the costs?

Costs over time
