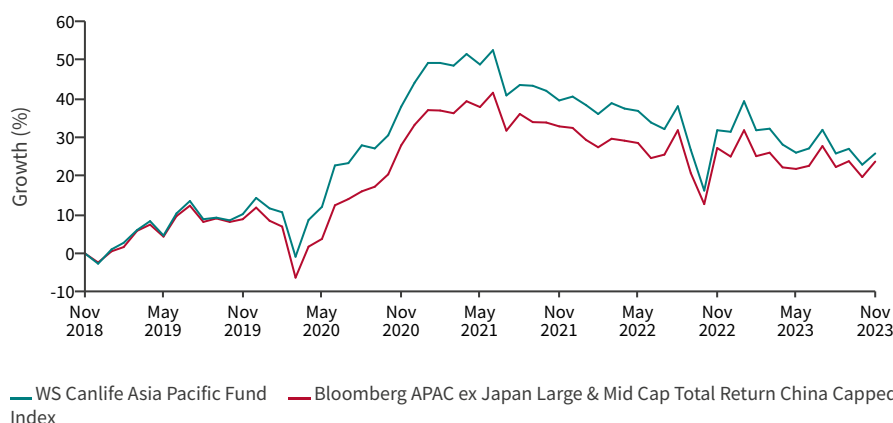
## Asia Pacific Fund
