## Objective

To generate growth over the long term (5 years or more) by investing in Global small-capitalisation equities (company shares).

**Performance Comparator:** Investment Association Global Equity Sector Average.

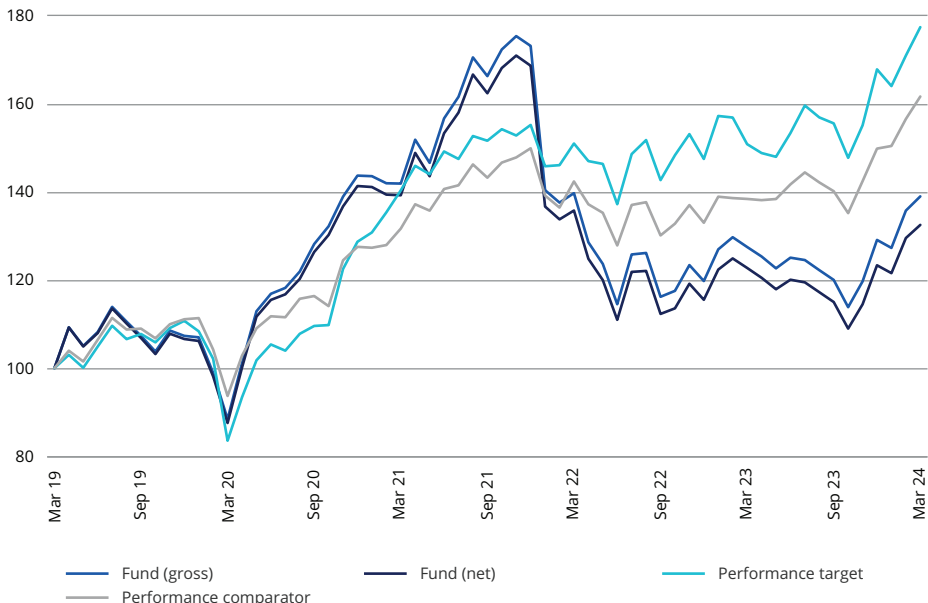
The MSCI AC Country World Small Cap Index (the "Index") is a representative index of world stock markets of smaller companies.

The Investment Association Global Equity Sector (the "Sector") is a representative group of investment funds with a focus on global equities.

## Portfolio securities

- The fund will invest at least 70% in equities of global smaller companies.
- Global smaller companies are defined as any company of a size similar to those in the Index.
- The fund may also invest in larger global companies.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.
