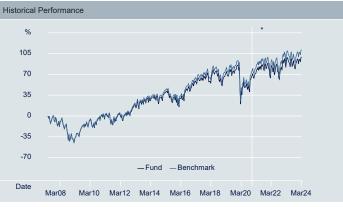

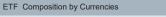
ETF Composition by Countries

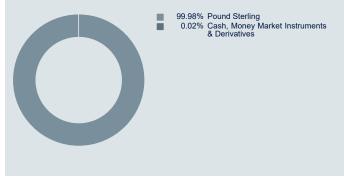


ETF Composition by Sectors
