

INDEX DESCRIPTION

The Index is comprised of "investment grade" corporate bonds (i.e. medium to high quality) which are denominated in EUR, GBP and USD, have at least 1.5 years remaining to maturity (i.e. the time until they become repayable) and pay a fixed-rate coupon (i.e. "interest"). The weight of each company's bonds within the Index depends on its "creditworthiness" (i.e. its ability to repay its debts) determined primarily by reference to its revenues, its debts and, depending on its industry sector, its assets, loans, earnings and cash flows. Each industry sector and geographical region's importance to the economy is also taken into account. The weights are then adjusted to prioritise companies with higher "liquidity" (a measure of how actively its bonds are traded) and higher "yields" (i.e. investment returns).
