#### Objective

To generate growth over the longer term (5 years or more) by investing in European smaller capitalisation equities (company shares).

**Performance Target:** To achieve the return of the FTSE Small Cap Developed Europe Index, plus 3% per annum over rolling five year periods (before charges). There is no certainty or promise that the Performance Target will be achieved.

The FTSE Small Cap Developed Europe Index (the "Index") is a representative index of the stock market for European smaller companies.

#### Portfolio securities

- The fund will invest at least 70% in equities of European (including UK) smaller companies.
- European smaller companies are defined as any company of a size similar to those in the Index.
- The fund may also invest in larger European companies.
- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.


