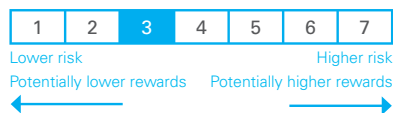

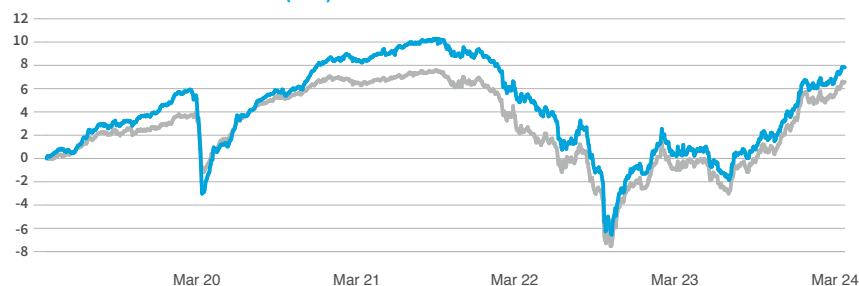

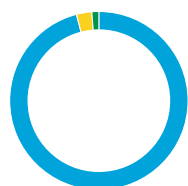
FUND SNAPSHOT

PORTFOLIO BREAKDOWN

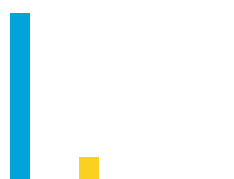
