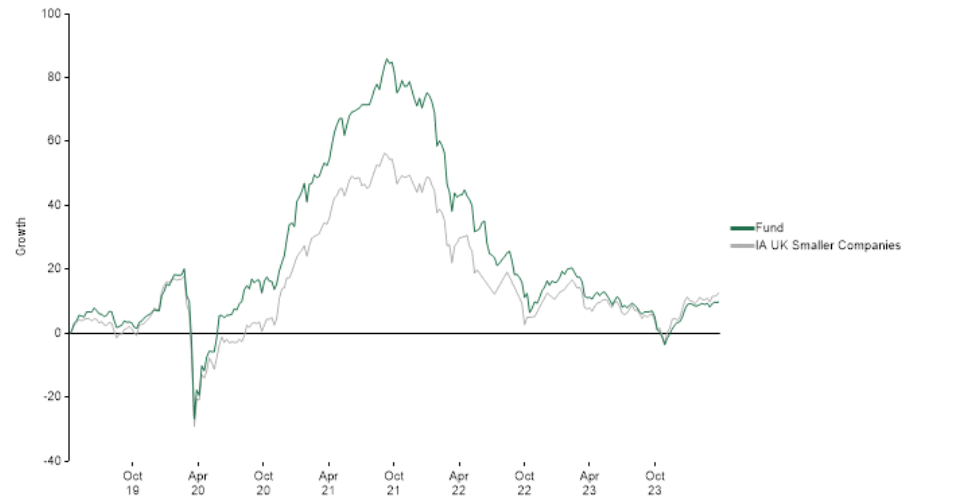

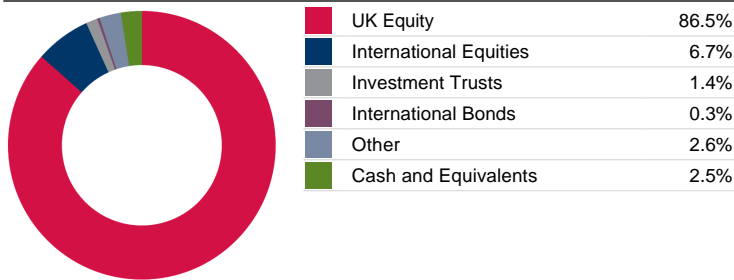

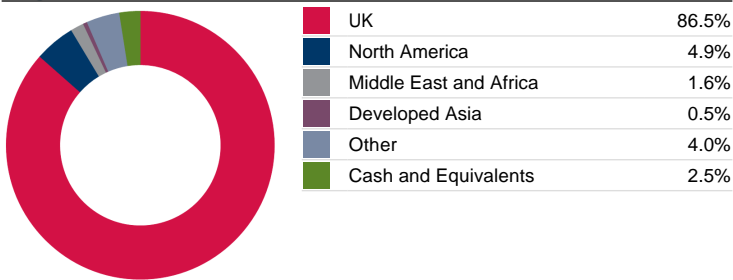

Regional Allocation



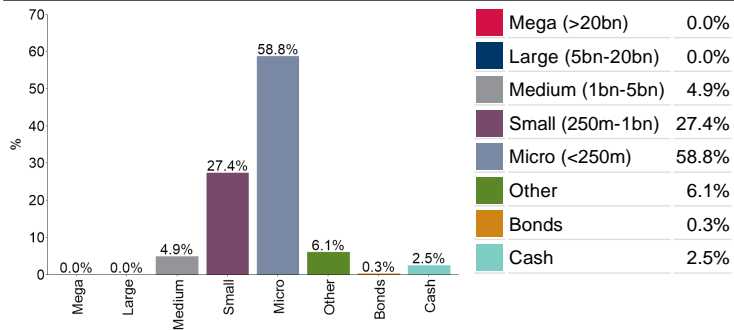
