## Investment policy







The Consumer Price Index is used to measure the rate of inflation. As performance data is produced prior to the publication of the latest monthly CPI data, the most recent figures are extrapolated one month until the ONS publish the latest figures. The latest figure may be higher or lower than that shown, and will be included in the following month's performance data. Please refer to the fund's Investment Objective for details regarding how achievement of the target return benchmark is measured, and over what time period. The fund's performance may also be compared against UK Equities represented by MSCI United Kingdom Index (£, net total return) and UK Government Bonds represented by ICE BofA UK Gilts Index (£). These comparator benchmarks have been selected as they assist in evaluating the fund's performance against the two principle asset classes that the fund may have exposure to. The share class of the fund was launched on 26 March 2010, performance figures do not exist before that time.
