INDEX DESCRIPTION

The Index is comprised of bonds issued by the governments of countries defined as "emerging market and developing countries" by the IMF, which are denominated in each country's local currency, have at least 1 year remaining to maturity (i.e. the time until they become repayable), pay a fixed-rate coupon (i.e. "interest") and may be of any credit rating or may be unrated. The weight of each country's bonds within the Index depends on its "creditworthiness" (i.e. its ability to repay its debts) determined primarily by reference to its level of public debt, its revenue and its social and political stability. The weights are then adjusted to prioritise countries with higher "liquidity" (a measure of how actively its bonds are traded) and higher "yields" (i.e. investment returns).
