An opportunistic fixed income strategy, designed to provide low correlation to core fixed income, offering current yield, low interest rate sensitivity and limited downside volatility.

- The Semper Total Return Fund is a UCITS which seeks to provide a high level of risk-adjusted current income and capital appreciation
- The Fund is invested in fixed income securities similar to Semper Capital Management's existing U.S.-domiciled MBS Total Return Strategy
- Investments are concentrated in U.S. Mortgage-Backed Securities (MBS) including Non-Agency and Agency MBS and related structured credit sectors including Commercial Mortgage-Backed Securities (CMBS) and Asset-Backed Securities (ABS)

FUND REVIEW

The U.S. Dollar SEMTIUU share class returned 0.93% in June, about one-third from interest income and two-thirds from price gains. Agency CRT bonds continued to be the largest contributor to price appreciation. The sector, with a 30% portfolio weight, rose an average of about one-half point in price. Subordinated profiles continued to strengthen from strong loan performance leading to growing credit enhancement and increasingly strong housing data. We continued to add attractive Mortgage Insurance CRT profiles while selling delevered Agency CRT Last Cash Flows, callable SFR bonds, and we further reduced Legacy bonds which continued to offer lower return potential than newer issues, although loan performance has been strong.

MARKET HIGHLIGHTS

RMBS sectors remained firm with increasingly strong fundamental data, 60% to 80% COVID Forbearance loans having cured, and good market technicals. Inflation concerns and a seeming shortening of the time until the Fed turns hawkish has pressured short term Treasury yields, but intermediate yields have stayed close to recent lows. Agency MBS have underperformed Treasuries, perhaps with the expectation of nearer term tapering of Fed MBS purchases. RMBS remain well positioned with lower duration, good cash flow quality and loan performance providing some insulation. The Fed increased the Interest on Excess Reserves by 5bps, the first sign of a lessening in stimulative Fed policy which may result in some upward pressure in SOFR and other short term rates, a positive for floating rate RMBS coupons and for RMBS portfolio yield.

OUTLOOK

Semper Capital's outlook remains unchanged and positive for the RMBS sector. Following a rally in intermediate Treasuries, we expect upward pressure on interest rates, and are maintaining lower duration with minimal 10-year and longer key rate duration and more than a 50% allocation to floating rate securities. Despite rising RMBS prices, yield expectations are stable/rising from increased quality of cash flows and rising forward rates. Mezzanine profiles continue to have significant value and upside, led by subordinated Agency CRT B2 profiles. The next new Agency CRT issuance by Freddie Mac later in July will provide a good barometer of near term value. If macro volatility picks up, we are prepared to defensively move higher in the RMBS capital stack.



GROWTH OF \$10,000 SINCE INCEPTION *




