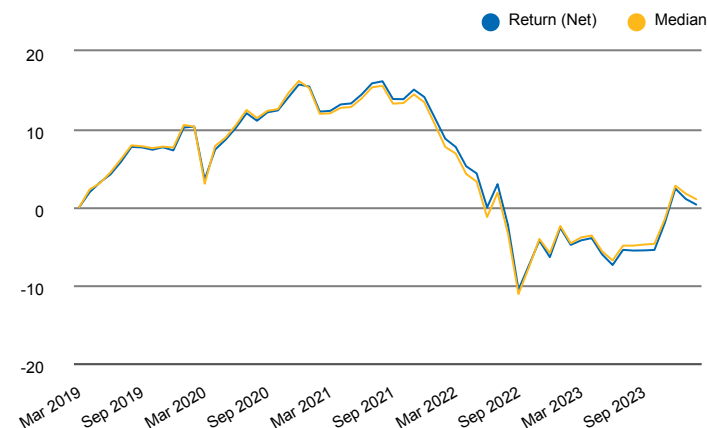

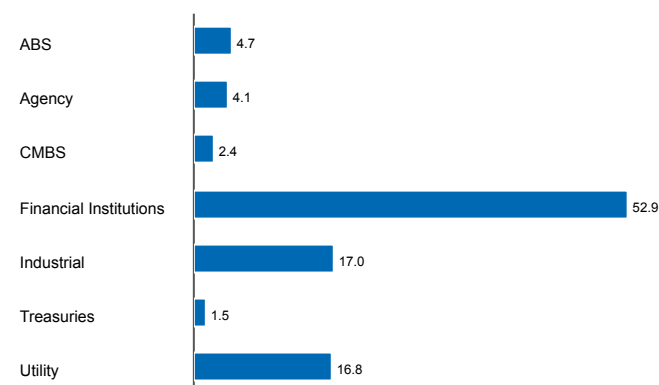

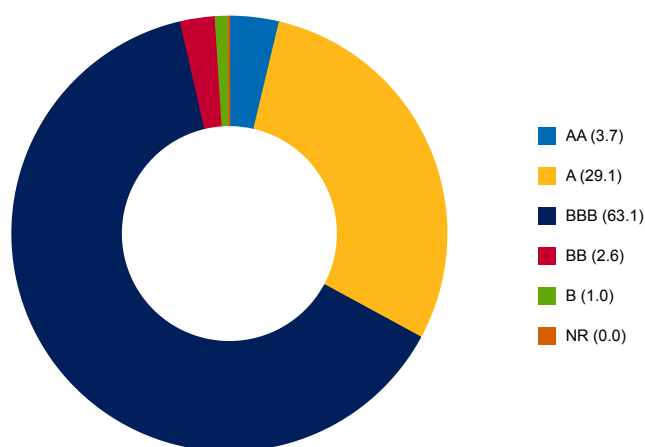

Sector allocation (%)



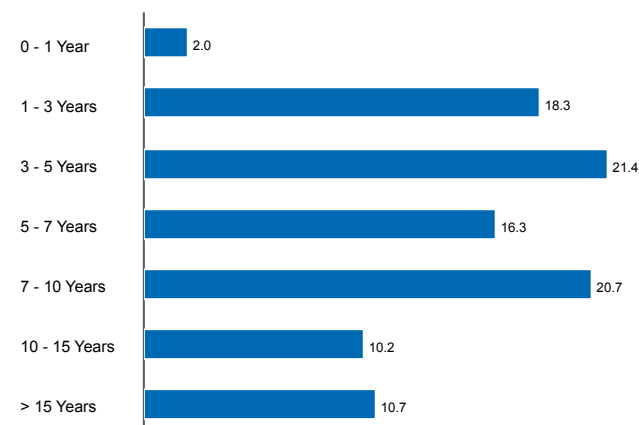
Ratings allocation (%)



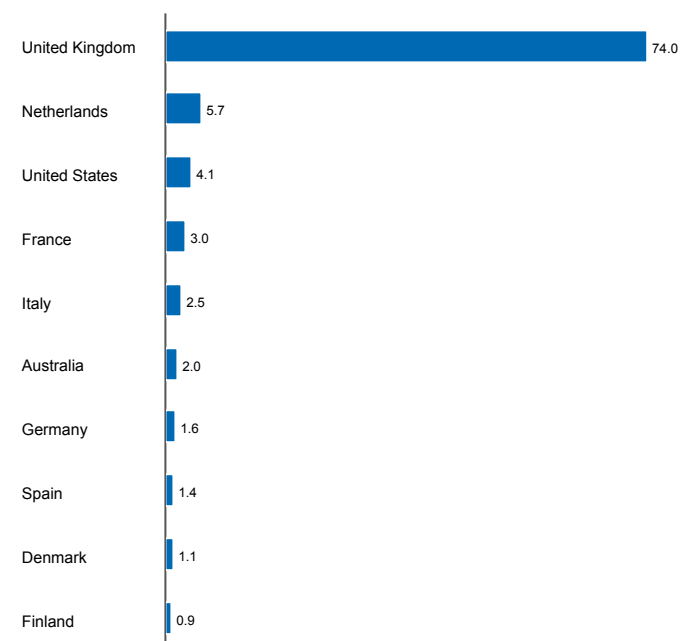
