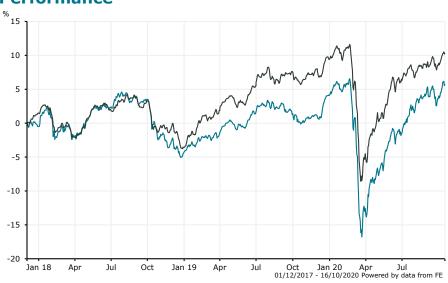

Fund Aim

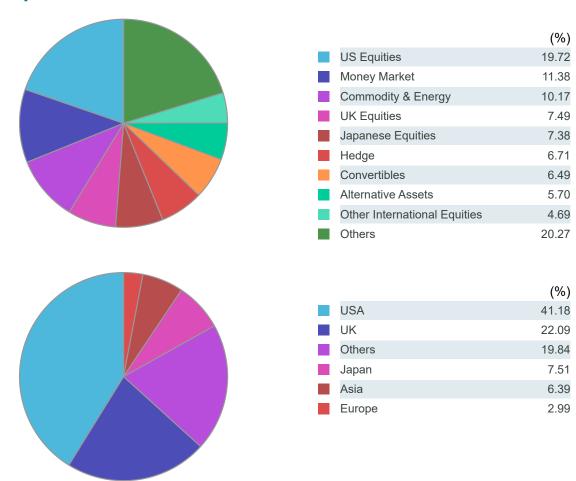
