These funds invest predominantly in a diversified portfolio of global equities.</p> <p>The Fund may invest in both actively managed and passive index tracking funds. 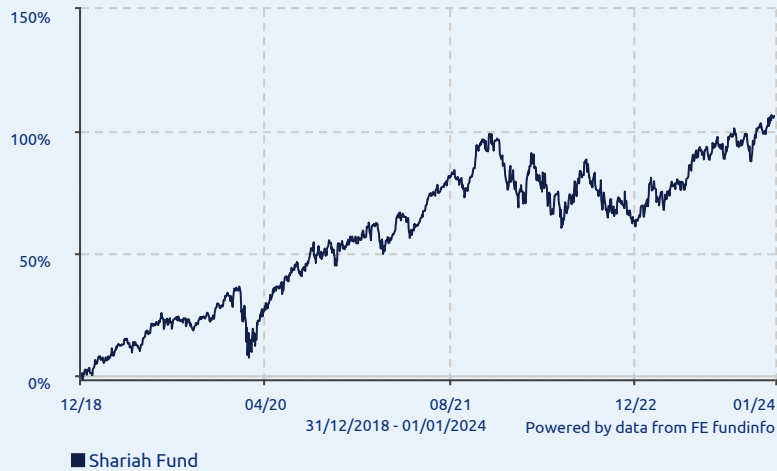
