	<p>This fund is also referred to as the SL Global Emerging Market Equity CP Pension Fund.</p> <p>The Fund aims to provide long-term growth by investing in one or more equity funds that aim to provide exposure to a portfolio of equities from emerging market countries.</p> <p>The underlying equities within the funds will cover a portfolio of emerging market equities across various countries, economic sectors and industries. The funds may also have the flexibility where appropriate to invest in equity-like securities, developed market equities and / or money market instruments.</p> <p>One or more of the underlying funds may have a bias towards a range of investment factors and may also apply Environmental, Social & Governance (ESG) strategies within their portfolios. These strategies may exclude companies that are involved in certain activities, and maybe managed with a particular ESG focus. These funds may also utilise a stewardship approach to encourage better conduct around ESG by using their voting rights where applicable. Further details on the strategies applied can be found in the underlying fund factsheets.</p> <p>The Fund may invest in both actively managed and passive index tracking funds. These funds may use derivatives for the purpose of efficient portfolio management, reduction of risk or to meet their respective investment objective if this is permitted and appropriate. The sterling value of overseas assets held in the Fund may rise and fall as a result of exchange rate fluctuations. Where the Fund invests in more than one fund, the allocation between these funds will be re-balanced periodically.</p> <p>The value of investments within the Fund can fall as well as rise and is not guaranteed – you may get back less than was paid in.</p> <p>The Fund has been selected by the Trustee Directors (that represents the Centrica Pension Scheme, Centrica Pension Plan and Centrica Engineers Pension Schemes) following receipt of advice from their independent adviser. 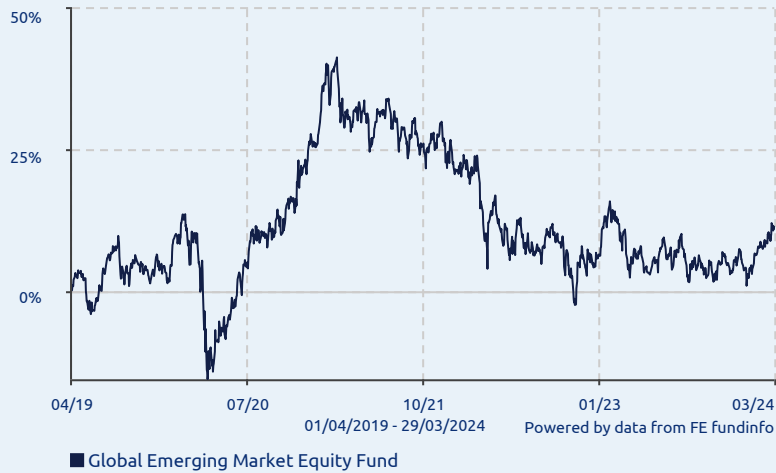
