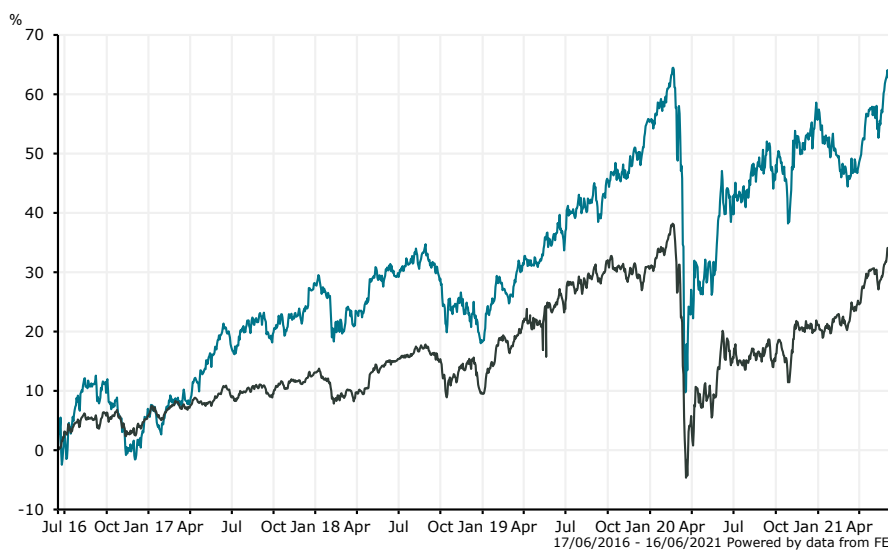

Fund Aim

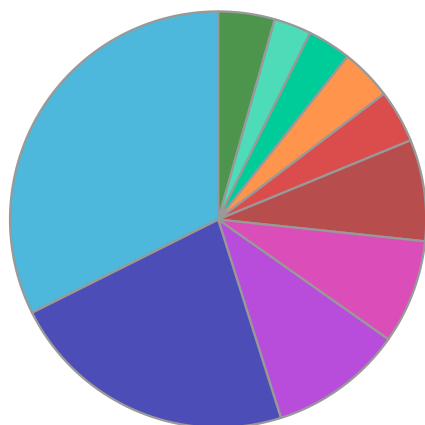

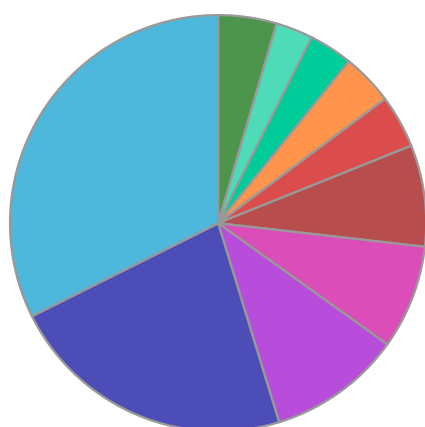
